

## CONFERENCE EXPLORES MARITIME SURVEILLANCE DEVELOPMENTS

The conference "Maritime Surveillance: Cooperation in Practice", held in EMSA on 7 May, provided an opportunity for interested member state and EU authorities to find out about the latest developments in maritime surveillance across Europe. A growing number of authorities are engaging an ever-increasing range of sea-based activities, and there is subsequently an increasing need for reliable maritime data. Clear themes emerging from the conference were: the critical role of cooperation between all actors; the importance of building on synergies; the potential of new technologies for further improving the maritime picture; and the importance of developing operational capacity in a 'bottom-up' manner. EMSA will continue to provide support through its Integrated Maritime Services, taking into account developments at sea and the evolving priorities of member states and the Commission.

## MAJOR UPDATE FOR EMCIP ACCIDENT INVESTIGATION PORTAL

The European Marine Casualty Investigation Platform, EMCIP, has successfully undergone a major update. Data entry is now easier thanks to a user-friendly web interface, an integrated quality control feature has reduced the need for data checks and a single-sign-on has been added. Information about marine casualties and incidents is collected and stored in EMCIP, in accordance with Directive 2009/18/EC. The data can be used by member states and the Commission to identify safety issues and support decision making. On the [EMCIP Portal](#) it is now possible for the public to find information about the most recent marine casualties and incidents, as well as investigation reports published by the member states.

## EMSA TAKES PART IN THE ANNUAL MEETING OF THE PARIS MOU

In May EMSA participated in the Paris MoU (PMOU) annual meeting in various capacities. The EMSA team provided technical assistance to the Commission during the meeting, took the leadership of two task forces reporting to the plenary, participated and commented in our capacity as database manager of the PMOU (THETIS) and provider of the eLearning and Rulecheck tools supporting the PSC officers of the PMOU and, finally, participated in policy discussions. During the meeting, EMSA provided extensive feedback on the visits-to-member-states programme as well as on the PSC training seminars which EMSA organises, hosts and for which it provides the lecturers. The meeting also agreed on new tasks for the following year, including various enhancements and amendments of the tools supported by EMSA. A key task where EMSA will be deeply involved over the course of next year will be the review of the PSC Directive and the Paris MoU text which proved difficult to implement.
